Dear Senator Berger, Senator Blue, Speaker Moore, and Representative Jackson:

North Carolina's nonprofit sector provides about 10% of private sector jobs in our state and like most other parts of the economy, continues to struggle in the face of the COVID-19 pandemic. The federal CARES Act included significant relief for charitable organizations by including nonprofits in new emergency loan programs, extending unemployment benefits to employees of religious organizations and small nonprofits, and providing a small tax incentive for charitable giving. The state COVID-19 Response Act also provides significant support that will help increase access to healthcare, food assistance, broadband, and other needs in North Carolina communities. Nonprofits are appreciative of this initial federal and state relief.

North Carolina's charitable nonprofits need further assistance from the General Assembly to help preserve their organizations' ability to provide essential services at this time of greatest need. Specifically, nonprofits need the following six state policy actions:

1. **Protect self-insured nonprofits.** Many 501(c)(3) nonprofits elect to reimburse the UI Trust Fund for the cost of their employees' unemployment claims rather than pay state unemployment tax. These self-insured nonprofits must keep 1% of their payroll in escrow with the Division of Employment Security at the NC Department of Commerce. Even nonprofits providing essential services during the COVID-19 crisis have had to lay off or furlough some of their employees. Without assistance in covering the costs of these unemployment claims, many nonprofits that provide health care, food assistance, affordable housing, childcare, and other critical services will have to end or curtail services later this year. The CARES Act provides funding to cover *half* of the costs of these nonprofits' COVID-19 related unemployment claims, but still leaves these organizations with significant financial liability to reimburse the UI Trust Fund for the other half of these costs at the end of 2020. ***The General Assembly can prevent further economic harm to these nonprofits either by covering the other half of the costs of their COVID-19 related unemployment claims from the UI Trust Fund or by delaying the date when self-insured nonprofits must reimburse the state for their COVID-19 related unemployment claims.***
2. **Exempt charitable nonprofits from paying sales tax in 2020.** Currently, most 501(c)(3) nonprofits pay sales tax on their purchases and can request semi-annual refunds of these taxes from the NC Department of Revenue (DOR). Because the COVID-19 crisis has forced many

nonprofits to exhaust their financial reserves, this delayed form of sales tax exemption reduces these organizations' capacity to provide immediate services like health care, childcare, and food assistance. ***The General Assembly can help improve nonprofits' immediate cash flow by temporarily allowing for point-of-sale exemption from sales tax instead of sales tax refunds for 2020 and directing DOR to make a simple change on the state's sales tax exemption certificate form.***

3. **Include nonprofits in small business relief.** Like small businesses, many nonprofits need immediate financial support to continue to operate and provide services. Nonprofits are grateful that Congress included nonprofits in the small business relief programs established in the CARES Act. ***As the General Assembly develops or expands loan programs, grants, or other measures to help small businesses, it is essential that nonprofits have full access to these programs.***
4. **Bolster charitable giving incentives.** The CARES Act created a temporary above-the-line charitable deduction for 2020, capped at \$300. While nonprofits appreciate this measure, the \$300 cap is unlikely to generate nearly enough new or increased donations to help nonprofits weather this crisis. ***The General Assembly can create a stronger incentive to increase private giving by temporarily reinstating the non-itemizer state tax credit for charitable contributions.***
5. **Facilitate remote meetings of nonprofit boards.** Governor Cooper has issued an executive order to help nonprofits hold membership meetings remotely during the COVID-19 crisis. However, some organizations are unable to conduct board meetings remotely and therefore are unable to take essential actions to ensure that their organizations can continue to provide programs and services. ***The General Assembly can help by temporarily amending the NC Nonprofit Corporation Act to allow all nonprofit boards to take action by email by unanimous written consent and to conduct meetings by remote communications such as conference calls.***
6. **Seek input from nonprofits.** Charitable nonprofits include hospitals, food banks, childcare providers, museums, senior centers, houses of worship, schools, theaters, research facilities, animal shelters, health clinics, housing assistance centers, transportation providers, and much more. Every day, these organizations work directly with a wide range of people in all 100 counties of the state. ***As the General Assembly determines additional state policy changes and funding to address the COVID-19 crisis, it is essential to consult with nonprofits to fully understand the current needs of communities through North Carolina. Specifically, legislators should seek input from nonprofits serving their districts and from statewide nonprofit organizations.***

Thank you for your continued leadership during this crisis. The COVID-19 Response Act was an important first step in helping North Carolina communities recover. We hope you and your colleagues in the General Assembly can make these additional state legislative changes to help nonprofits continue to provide essential services in our communities.
